
## Let's make sure we all get home safely

- "I cared about my colleague when I handed him a headlamp for his helmet, since it gets really dark in the afternoon."
- "I filled up my colleague's water bottle when I went to fill up my own."



## In Ørsted we use life-saving rules to improve safety



The life-saving rules are based on industry safety performance data, representing the **activities**, **hazards**, and **missing barriers** which contribute to the highest frequency of fatal incidents.



Always ensure the required plans and permits are in place before you start a job



Never work, or operate vehicles or machinery, while under the influence of drugs or alcohol



Always use tools and equipment that are fit for the intended purpose



Never undertake any job unless you have been trained and assessed as competent



Always verify isolation and zero energy before work begins



Always use fall protection when working at height



Always secure tools, loose materials and equipment to prevent them from falling

Never place yourself under a suspended load during lifting

Always adhere to barriers and exclusion zones



Only transfer from a vessel when you are ready, and permission is provided
